**Summary:** Fusidic acid 1% w/w Viscous Eye Drops - Amdipharm UK Limited

The MA Holder is the sole supplier of this product in UK.

To ensure continuity in supply, Amdipharm UK Limited has obtained approval from the Medicines and Healthcare products Regulatory Agency (MHRA) to supply *the repacked product for UK Market which was originally manufactured for the Chinese market. The repacked product* is expected to be on the UK market starting from May 2025.




**Please note the following:**
