## Sodium Cromoglicate 2% w/v Eye Drops, solution

Sodium cromoglicate

Read all of this leaflet carefully before you start using this medicine because it contains important information for you.

- This medicine has been prescribed for you only. Do not pass it on to others. It may harm them, even if their signs of illness are the same as yours.

## 1. WHAT THIS MEDICINE IS AND WHAT IT IS USED FOR This medicine contains sodium cromoglicate which belongs to a group of medicines

called anti-allergics. It works by stopping the release of the natural substances in your eyes that can lead to

an allergic reaction. Signs of an allergic reaction include itchy, watery, red or inflamed eyes and puffy eyelids. This medicine is used for the prevention, relief and treatment of eye allergies.

This includes: Short and long term allergic conjunctivitis (inflammation of parts of the eye)

- More severe cases of conjunctivitis ('vernal keratoconjunctivitis'). Signs include
- bumps inside the upper eyelid, sensitivity to light and severe itching. 2. WHAT YOU NEED TO KNOW BEFORE YOU USE THIS MEDICINE

## Do not use this medicine:

 If you are allergic (hypersensitive) to sodium cromoglicate or any of the other ingredients of this medicine (listed in Section 6)

Signs of an allergic reaction include: a rash, swallowing or breathing problems, swelling of your lips, face, throat, tongue and worsening of redness, itching or swelling of the eye

Do not use this medicine if the above applies to you. If you are not sure, talk to your doctor or pharmacist before using these eye drops. Warnings and precautions

This medicine contains 100 micrograms of benzalkonium chloride in each ml

Benzalkonium chloride may also cause eye irritation, especially if you have dry eyes or disorders of the cornea (the clear layer at the front of the eye). If you feel abnormal eye sensation, stinging or pain in the eye after using this medicine, talk to your doctor.

3. HOW TO USE THIS MEDICINE

 Before using the medication for the first time, be sure that the tamper-proof seal on the bottle neck is unbroken. A gap between

 Squeeze one or two drops inside the lower lid without touching your eye. Close your eye.

the bottle and the cap is normal for an unopened bottle.

- Always put the cap back on the bottle as soon as you have used it. Repeat in the other eye if needed. How much to use (adults, elderly and children) One or two drops in each eye four times a day, or as directed by your doctor.
- If you use more of this medicine than you should Talk to your doctor or pharmacist or go to the hospital straight away. Remember to take any medicine that is left with you so the doctor knows what you have used.

If this medicine is accidentally swallowed, talk to your doctor or pharmacist.

### If you forget to use this medicine If you forget a dose, use your drops as soon as you remember.

However, if it is nearly time for your next dose, skip the missed dose. Do not use a double dose to make up for a forgotten dose.

If you stop using this medicine Keep using these eye drops until your doctor tells you to stop. Do not stop using the eye drops just because your eyes feel better.

4. POSSIBLE SIDE EFFECTS

Like all medicines, this medicine can cause side effects, although not everybody


# Stop using this medicine and see a doctor as soon as possible if:

• The itching, redness or swelling gets worse. You may be allergic to this medicine. Talk to your doctor or pharmacist if any of the side effects get serious or last longer than a few days, or if you notice any side effects not listed in this leaflet:

### Stinging or burning in your eyes or blurring of eyesight. This should only last for a short time and occur immediately after using the eye drops.

- Mild eye irritation.

Reporting of side effects If you get any side effects, talk to your doctor, pharmacist or nurse. This includes any possible side effects not listed in this leaflet. You can also report side effects directly via the Yellow Card Scheme (www.mhra.gov.uk/yellowcard or search for MHRA Yellow Card in the Google Play or Apple App Store). By reporting side effects you can help provide more information on the safety of this medicine.



## **5. HOW TO STORE THIS MEDICINE**

Keep this medicine out of the sight and reach of children.

Do not use this medicine after the expiry date which is stated on the bottle, label and carton after EXP. The expiry date refers to the last day of that month.

This medicine does not require any special storage conditions before opening the bottle. After opening the bottle, do not store above 25°C. This medicine is sterile when you buy it, so you must not keep it for more than four weeks after opening the bottle.

Do not throw away any medicines via wastewater or household waste. Ask your pharmacist how to throw away medicines you no longer use. These measures will help protect the environment.

## 6. CONTENTS OF THE PACK AND OTHER INFORMATION

## What this medicine contains

- The active substance is sodium cromoglicate. 1ml of eye drops contains 20mg of sodium cromoglicate.
- The other ingredients are disodium edetate, benzalkonium chloride and water for injections.

# What this medicine looks like and contents of the pack

Sodium Cromoglicate Eye drops is a clear colourless to pale yellow solution supplied in either a 5ml, 10ml or 13.5ml plastic dropper bottle with a tamper-proof cap.
