1. What Boots DermaCare Skin Allergy Relief Cream is and what it is used for

Boots DermaCare Skin Allergy Relief Cream is intended for the relief of minor discomforts due to allergic conditions of the skin. Such conditions include rashes and itches, stings and insect bites. The active ingredient is diphenhydramine hydrochloride which is an antihistamine; it works by reducing the inflammatory response to histamine, which is an agent responsible for causing the pain associated with allergic responses.

2. What you need to know before you use Boots DermaCare Skin Allergy Relief Cream

Do not use Boots DermaCare Skin Allergy Relief Cream

- If you are allergic to Diphenhydramine Hydrochloride or any of the ingredients listed in section 6.

- Do not apply to eczema, or conditions where the skin is broken or producing any form of wet discharge.
- Do not use the cream at the same time as using other products that also contain diphenhydramine.
- In children under 6 years old.

Warnings and precautions

Keep away from the eyes, nose and mouth. Apply sparingly, avoiding prolonged or repeated applications especially to large areas. If burning or a rash develops or the condition does not improve seek medical advice immediately. You can remove the cream by washing with soap and water if required.

3. How to use Boots DermaCare Skin Allergy Relief Cream
